Toronto, ON "I am writing with regards to KMA Contracting's implementation of the TransCanada Screen and Halton Hills Monument, which is located on the north side of Highway 401 in a prominent location in front of TransCanada's new generating station in Halton Hills. The screen and monument were designed as urban design features to transmit a character of prestige development to TransCanada's large project and to convey a sense of identity to Halton Hills' new prestige employment area.

The screen design, scaled to the highway, is an illuminated steel arc of approximately 160 metres in length. It is comprised of a cantilevered steel tube 650mm in diameter, that is curved along its length, with cables forming a pattern from a steel linear member at the caisson foundation base, up to the tube. The design is augmented with LED tube lighting and LED accent lighting spots at the sloped vertical double column supports. A monument of exposed sandblasted concrete and large backlit individual logo elements combines with the screen to provide civic identification.

The project's bold aesthetic is deceptively simple, as it involved several construction complexities. Coordination of caisson foundation placement and steel base members with the long arced top involved detailed setting out of complex geometries on site along a newly constructed berm. Each foundation needed to be accurately set individually upon different axis lines, that were radial to the arc causing varying bolt placements. Further coordination of steel fabrication with cable installation also involved complex geometry with different steel geometry, welds and connections at each location. Construction of the main tube involved coordination of steel slip joints at several locations along its length to enable the staged construction sequence required for this length. Coordination of electrical provisions for the LED lighting also needed to be done with care for both the screen and monument elements.

KMA proved to be more than equal to the task. Their professionalism and dedication to the project's objectives resulted in a successful completion on time and on budget. Their methodology of partnership with the designers and Owner resulted in a construction process that was both efficient and enjoyable.

Most importantly, their commitment to the intended aesthetic and to retaining design integrity resulted in a realized project of which we are all proud.
